we'll see for a while, as far as grass fire goes."






2009 was one of Queensland's worst bushfire seasons on record. During one 36-day period, fire fighters attended 4491 vegetation fires and many of these threatened homes and lives.

Malone Review into the Queensland Rural Fire Service

The management of fire risk should take place at the District level through the establishment of **District Fire Management** Groups which, through legislation, will be required to produce an annual Fire Risk Management Plan.

Local Government Areas

Recommendation 36: That to assist the Rural Fire Service Queensland and other agencies in managing wildfire risk, a planning system for wildfire management be established in legislation that complements the existing disaster management arrangements.

Recommendation 37: That the planning system is to have a two tiered structure comprising District Fire Management Groups and linking to the State Disaster Management Group.

Recommendations 38 – 41:- Requires RFSQ to set up Fire Management Groups throughout Queensland with a minimum of one group per RFSQ Area. Also a plan to be developed by each group in regards to addressing the bushfire risk within the area by:

- > \(\begin{align*} \epsilon \) stablish common goals for mitigation action
- > put in place agreed actions for implementation in response to wildfire threats
- > identify the impediments to more effective collaboration
- > build links between agencies and individuals.

To protect persons, property and the environment from fire and to provide an advisory service, and undertake other measures, to promote fire prevention and fire control;






"Emergency Services Minister Joe Francis says the State cannot afford to "bind the Crown" to the same bushfire mitigation rules faced by private landowners. It is the first indication that Cabinet will be unable to fulfil the recommendation of the Department of Fire and Emergency Services for a consistent approach to fuel load reduction no matter who owns the land. Mr Francis conceded that if private landowners were forced to put in fire breaks and reduce fuel loads, then "morally" local, State and Federal governments should, too. But he said it was legally and constitutionally difficult to tell the Commonwealth what to do with its land, and the State owned so much that continuing mitigation would be prohibitively expensive."

Recommendation 16: That a Rural Fire Research and Investigation Team be established to coordinate and communicate fire research knowledge, including fire behaviour as well as coordinate fire investigations and complaints for the state.



RESEARCH

M16: It is essential that the Rural Fire Service Queensland be at the forefront of research into fire behaviour to ensure appropriate and modern systems of fire management are maintained.

District Fire Management Groups will require input from researchers on the best approach to managing fire risk in their local landscape. These staff will provide the link between the latest research and the formulation of the DFMG plan. The positions will also be responsible for ensuring fire behaviour knowledge is disseminated across the districts.

INVESTIGATION

M16: A position of Fire Investigator is to be established in the team to lead fire investigations and develop policy, procedures and training on fire investigation. This role will be the co-coordinator of fire investigations and complaints for the State.

A significant point of frustration for Fire Wardens and Brigade members alike was the perceived lack of action from authorities in the prosecution of people who break the law by lighting fires without a permit.
